Participation Terms and Conditions

1. Promotion:

- 1.1. The Mauritius Commercial Bank Seychelles Limited (hereinafter referred to as "MCB Seychelles"), whose registered office is at Caravelle House, Manglier Street, Victoria, Mahé, Seychelles proposes this promotional offer, (hereinafter referred to as the "Offer") to which the following Terms and Conditions shall apply.
- 1.2. The Offer is valid from 9th March to 15th April 2026 [both dates inclusive], (hereinafter referred to as the "Promotional Period").
- 1.3. A lottery draw shall be held during the month of May 2026 to award a prize to one lucky winner ("hereinafter referred to as the Winner").
- 1.4. The Winner shall be prized a package for two (2) persons to attend a FIFA World Cup 2026™ Semi-Final Match in the United States, comprising airfare, match tickets, accommodation and excursions (hereinafter referred to as the "Prize").
- 1.5. The Prize shall be strictly allocated to the Winner and shall not be assigned, transferred, redeemed in cash, sold, refunded, exchanged or otherwise disposed of.

2. Eligibility:

- 2.1. MCB Seychelles individual customers aged 18 years and above, holding a valid MCB Seychelles Visa Classic debit card, Visa Platinum debit card, Visa Classic credit card or Visa Gold credit card, residing in Seychelles, shall be eligible for the Offer (hereinafter referred to as the "Participant(s)").
- 2.2. One (1) entry to the lottery draw shall be allocated to the Participant for each approved payment of SCR 100 effected at either at a Point-of-Sale (POS) terminal or an e-commerce/online site, and payments made with Visa Classic credit cards and Visa Gold credit cards shall qualify for double entries, during the Promotional Period only (hereinafter referred to as an "Eligible Payments"). Participants shall participate in the lucky draw subject to the criteria set out in these Terms and Conditions.
 - 2.2.1. The number of transactions made during the Promotional Period will be counted to determine the number of entries obtained by the said Participants.
 - 2.2.2. Card transactions will be counted at the primary cardholder level. Thus, transactions carried out on secondary card(s), will be cumulated to the transactions made by the primary cardholder, to determine the total number of transactions made.

3. Ineligibility:

- 3.1. MCB Seychelles employees, customers under 18 years of age and MCB Visa Business cardholders are not eligible to participate in this Offer.
- 3.2. Primary and secondary cardholders, with overdue credit card payments and/or overdue loan installments and/or subject to recovery procedures on any credit facilities from the Bank, are also excluded from this Offer.

4. General Terms and Conditions:

- 4.1. By participating in this Offer, the Participants acknowledge that they have read and understood these Terms and Conditions and agree to be bound to them.
- 4.2. The recording of transactions carried out locally or abroad, either at Point-of-Sale (POS) terminals or e-commerce/online sites, shall be computed on the date of authorisation for each transaction within the Promotional Period.
- 4.3. Transactions done at automated teller machines (ATMs), at bank counters (any bank), at financial institutions, in casinos, all forms of betting, as well as payments or transactions in cryptocurrency, will not be considered for this Offer.
- 4.4. The current or savings account linked to a card must be in good standing and managed appropriately and satisfactorily, at the discretion of MCB Seychelles. In the event that the account is voluntarily or involuntarily closed, terminated or blocked, for any reason, before, during or after the Promotional Period, MCB Seychelles reserves the right not to offer the Prize.
- 4.5. In accepting the Prize, the Winner grants MCB Seychelles the right to publish his/her name and photo(s) in the press and on relevant communication media identified by MCB Seychelles. The Winner may be requested to appear in the national/international press or in the Bank's promotional (physical or digital) platforms. The Winner agrees to share images of the trip and events attended for MCB Seychelles' public relations and marketing purposes.
- 4.6. The lottery draw to determine the Winner shall take place at MCB Seychelles, Victoria Main Branch at Caravelle House, Victoria, Mahé, in the presence of a representative of the Seychelles police.
- 4.7. The Winner shall be contacted by phone on the his/her contact number(s) as listed in the Bank's records.
- 4.8. MCB Seychelles reserves the right to review and modify the above Terms and Conditions and notice of such changes shall be made available and published on the MCB Seychelles website as applicable.
- 4.9. MCB Seychelles shall not be liable for any failure to fulfill, or delay in fulfilling, any obligation under this Offer where such failure or delay is caused by events beyond their reasonable control, including but not limited to acts of God, natural disasters, war, terrorism, civil unrest, strikes, lockouts, government actions, pandemics, epidemics, power or communication failures, or any other events of a similar nature. In the event of such a force majeure occurrence, MCB Seychelles reserves the right to suspend, modify, or cancel the Offer, or any part of it, without incurring any liability to Participants.
- 4.10. MCB Seychelles shall not be held responsible or liable to a Winner should the suppliers of the Prize fail to provide the Prize, or for unsatisfactory quality of the Prize, or any related services or any acts or omissions or delays on behalf of third-party partners who may be involved in supplying the Prize.
- 4.11. MCB Seychelles is, under no circumstance, liable to a Winner or third-party, for any damage, loss, refund, inability from the Winner to benefit from the Prize or failure/inability from the third-party to provide the Prize.
- 4.12. The Offer and its Terms and Conditions are governed by the Laws of the Seychelles and in the event of any disagreement with the above Terms and Conditions, MCB Seychelles' decision will be final and without appeal.
- 4.13. MCB Seychelles will finalise all travel arrangements for the Winner and the accompanying person by the beginning of July 2026.
- 4.14. The Winner, as well as the person accompanying him/her, must each have a valid passport and any other relevant travel document.
- 4.15. MCB Seychelles cannot be held responsible if the Winner cannot avail himself/herself of the Prize for a specific reason, or in the case of a dispute relating to the application of these Terms and Conditions.
- 4.16. The Prize shall not be awarded to any cardholder residing in Seychelles who, at the time of draw or at the time of travel, holds a nationality which is subject to any U.S. Government travel ban, entry suspension or visa restriction, as may be amended from time to time. MCB Seychelles reserves the right to disqualify any Winner who is unable to satisfy U.S. entry requirements or obtain the necessary travel authorisation.
